Tony Padgett has been training stockdogs and competing for over 30 years. Tony has started young dogs, put the finish on mature dogs, hosted clinics and given handler lessons to folks training for competition and stockmen just needing a handle on their ranch or farm dog.

He has judged numerous ASCA Final competitions as well as National stockdog trials since becoming a stockdog judge 26 years ago. Tony has qualified several Aussies for Finals in cattle and sheep and earned multiple WTCH titles on Australian Shepherds as well as other breeds in the ASCA Stockdog Program through the years.

# Coosawattee Aussies Livestock Clinics and Livestock Handling

\*\*\*\*\***Read this Document Carefully**\*\*\*\*\*

**In consideration for participating in the Coosawattee Cattle Clinic and the WASCOF GA Stockdog Trials, the undersigned agrees as follows:**

*WAIVER – No fees will be processed without an accompanying signed waiver.*

**I will keep my dog under my direct control at all times. This means that I will keep my dog restrained on a leash unless we are actively engaged in working livestock under the direction of the trainer.**

**I understand that participation in a herding dog training lesson and or clinics is inherently dangerous due to the unpredictability of the activity and nature of both dogs and livestock.** This activity exposes my dog and I to above normal risks of personal injury, and my property to above normal risks of damage. **I am participating in this clinic or lesson and/or arena trials at my own risk.**

**AGREEMENT TO HOLD HARMLESS WAIVER & ASSUMPTION OF RISK:**

In consideration for participation in this event and/or clinic, I agree to assume all responsibility for any claim, loss, of damage of whatever kind or nature, whether to person or property, which may be caused at or near this event or clinic, either directly or indirectly, by me or the dog(s) I have entered in or brought to this event. 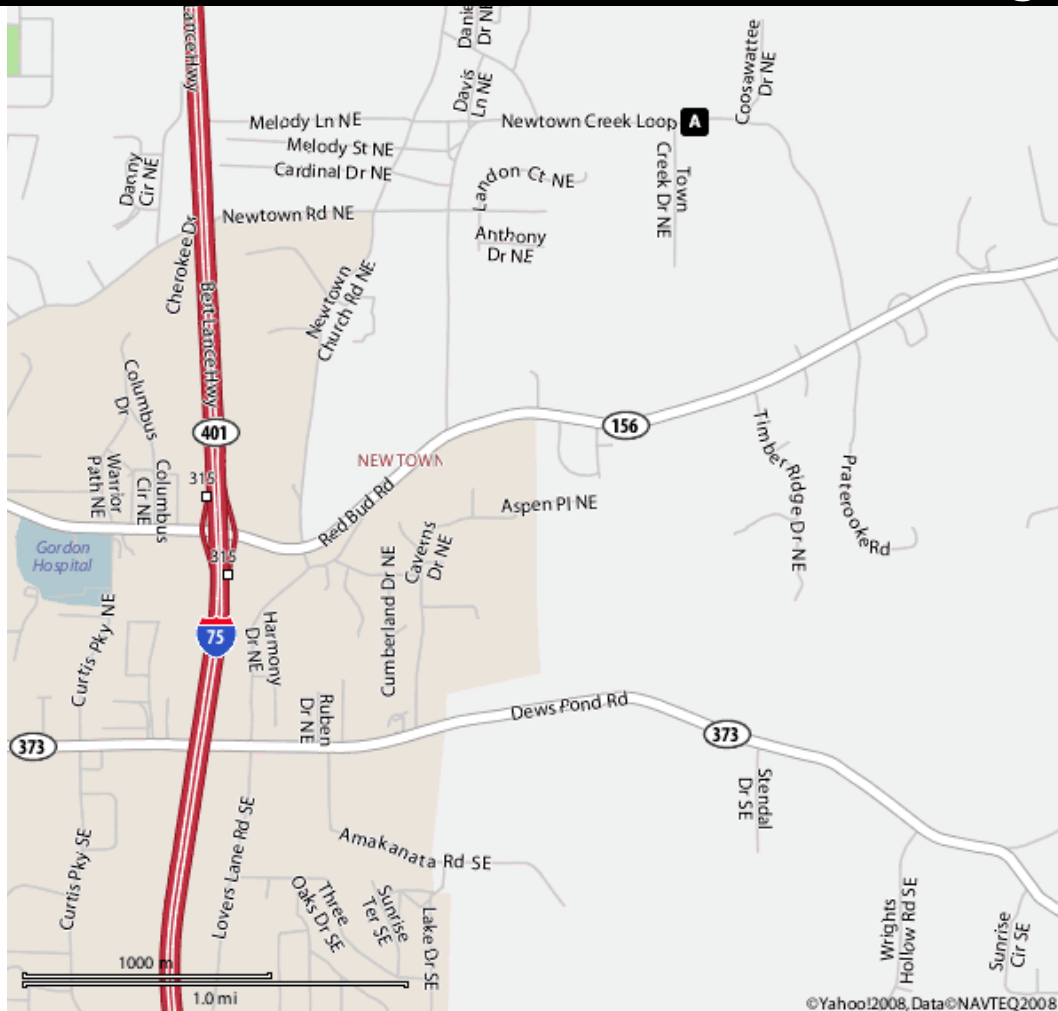
